

# Terms and Conditions

## 1. Promoter Details

The promoter of this competition is **Jobable Solutions Ltd**, company number 15693929, whose registered office is at 53 Twyford Road, Eastleigh, SO50 4HH.

## 2. Eligibility

- The competition is open to businesses based in the United Kingdom.
- Entry is available to businesses that are new to Jobable only.
- Existing Jobable customers are not eligible to enter.
- Entrants must be aged 18 years or over and authorised to enter on behalf of the business they represent.
- Employees of Jobable Solutions Ltd, Installer, their immediate families and any third parties directly associated with the administration of the competition are excluded from entry.
- A maximum of three entries per eligible business is permitted, as set out below.

## 3. How to Enter

- Entry is free of charge and no purchase is necessary.
- To enter, participants must complete and submit the competition entry form on the InstallerONLINE competition page.
- Completing the entry form provides the entrant with **one entry** into the prize draw.
- After submitting the entry form, entrants will be given the opportunity to book a live demonstration of Jobable.
- Entrants who book a Jobable demonstration through the competition demo booking link will receive **two additional entries**, giving them a maximum of **three entries** in total.
- The demonstration takes approximately 30 minutes and there is no obligation to purchase Jobable as a result of attending or booking the demonstration.
- Additional entries will only be awarded where Jobable can verify that the demonstration booking relates to the same eligible business and entrant who completed the original competition form.
- The competition closes at **23:59 on 13 November 2026**. Entries or qualifying demo bookings received after the closing date will not be included in the prize draw.
- Entrants are responsible for providing accurate contact information so that they can be contacted if selected as the winner.

## 4. Prize Details

- The prize is **12 months of Jobable subscription fees free of charge**, up to a maximum combined value of **£5,000 + VAT**.
